Commentary:

We have seen an increase of Leave of Absence requests and would like to kindly remind parents of the following:

As per our Attendance Policy, granting a leave of absence will only be made in exceptional circumstances. Each application will be considered individually considering the specific facts and circumstances and relevant background context behind the request.

It is extremely unlikely that a leave of absence will be granted for the purposes of a family holiday.

To request a leave of absence please follow the procedures below:

- Complete a Leave of Absence form which are readily available from the main school office. The form will

require details of your child and both parents and a reason must be provided as to why the leave has been requested.

-The form must be completed and returned to school at least 30 days before the absence.

This will then be reviewed by the Headteacher and the Attendance Lead.

You will receive written confirmation that your request has been approved or denied.

In line with legislation and our attendance policy we will ask the local authority to issue you with a penalty notice if you choose to remove your child and take this unauthorised leave in the absence of any exceptional circumstances.

Please be advised that parents who fail to ensure their child's regular attendance can be fined £60 (per parent, per child). If payment to the local authority is not made within 21 days (of a penalty notice being issued) the penalty will rise to £120 (per parent, per child).

Should the penalty not be paid, parent(s) will then be prosecuted under S444(1) of the Education Act 1996.
